

Refund & Cancellation Policy

Effective Date: August 4, 2026

Thank you for joining The Heather Style. This Refund & Cancellation Policy explains how membership billing, renewals, cancellations, refunds, and membership access are handled.

By purchasing a membership, you agree to this policy.

Membership Billing

The Heather Style offers monthly and annual membership plans.

Monthly memberships are billed once each month on the same calendar day that you originally subscribed.

Annual memberships are billed once each year on the anniversary of your original subscription date.

Membership Period

For purposes of this policy, the "Membership Period" means the period beginning on the date your subscription payment is successfully processed and ending immediately before your next scheduled renewal date.

Your membership provides access to all content available during your active Membership Period, including newly released content published during that time.

Automatic Renewal

All memberships automatically renew using the payment method on file unless canceled before the next scheduled renewal date.

By subscribing, you authorize The Heather Style to charge your selected payment method for each renewal until your membership is canceled.

How to Cancel

You may cancel your membership at any time.

Submitting a cancellation request stops future automatic renewals. Your current Membership Period will not be interrupted.

When Membership Access Ends

If you cancel your membership, your access will remain active through the end of the Membership Period that has already been paid for.

After your current Membership Period expires, your access to member only content, downloads, and other membership benefits will automatically end unless you renew your membership.

Refund Policy

Membership fees are non refundable.

We do not offer full or partial refunds for:

- Monthly memberships
- Annual memberships
- Automatic renewals
- Partial billing periods
- Unused membership time

If you cancel after your subscription renews, the renewal payment is non refundable.

Failed Payments

If a scheduled payment cannot be processed, we will notify you by email.

You will have five (5) calendar days to update your payment information or provide a new payment method.

If payment is not successfully received within that period, your membership access may be suspended or terminated until payment is received.

Subscription Pricing

Membership pricing may change at any time.

Price changes apply only to future subscriptions.

If a lower membership price becomes available, you may cancel your current subscription and subscribe again at the lower rate.

If your membership ends because your subscription is canceled or a payment is not successfully processed, any future subscription will be billed at the membership price in effect on the date you resubscribe.
